INTRODUCTION

Children attending Humpty Dumpty Childcare are consistently well supervised and our provider is committed to providing the best care for your child(ren). However, accidents do happen in any childcare setting.

By enrolling your child and signing this agreement, you acknowledge and accept the following terms regarding assumption of risk, policy compliance, and indemnification.

ASSUMPTION OF RISK

I assume all risk of injury or harm to my child(ren) associated with participation in Humpty Dumpty Childcare services, which are related to, arise out of, or are in any way connected with participation in childcare, including but not limited to: medical conditions, illness, communicable disease, omissions, injuries, property damage, or incidents regardless of cause or arising by reason of or during participation.

While Humpty Dumpty Childcare maintains the highest standards of safety and supervision, participation in a group childcare setting carries inherent risks of common childhood illness and minor accidents. By enrolling your child, you acknowledge and assume these ordinary and inherent risks.

POLICY COMPLIANCE & HANDBOOK ACKNOWLEDGMENT

- I have received the Humpty Dumpty Childcare Parent Handbook and all associated enrollment documents.
- I agree to abide by all policies and procedures as stated in the Handbook and associated forms.
- I understand that if I fail to abide by the policies or have not fully carried out the Parent Agreement, Humpty Dumpty Childcare has the right to suspend or terminate services. A verbal notice, followed by a written notice stating the conditions and reasons, will be provided.
- I understand that I may request a phone conference or personal meeting with the Provider to discuss any questions or concerns regarding these policies.

RELEASE, INDEMNIFICATION & HOLD HARMLESS AGREEMENT

I, the undersigned, being the lawful parent and/or legal guardian of the child(ren) listed below, hereby consent to my child(ren) participating in and receiving care and services provided by Humpty Dumpty Childcare. I agree to release, indemnify, defend, and discharge, and hereby hold harmless and waive any claims against Humpty Dumpty Childcare, SMARTTECH Early Learning LLC, Azahir Medani, their childcare staff, employees, consultants, contractors, and volunteers from any and all liability, claims, demands, actions, or rights of action, whether for personal injury, illness, communicable disease, property damage, or any other loss arising from or related to participation in childcare services at Humpty Dumpty Childcare.

This release applies to the fullest extent permitted by Massachusetts law and covers all activities, excursions, and events associated with the childcare program.

- Initials: I understand that Humpty Dumpty Childcare does not provide transportation and that I am responsible for all drop-off and pick-up of my child.
