SUBJECT: MANDATORY IMMUNIZATION REQUIREMENTS FOR CHILD CARE ENROLLMENT

In accordance with Massachusetts Department of Early Education and Care (EEC) regulations (606 CMR 7.05) and the Department of Public Health's immunization requirements for school attendance (105 CMR 220.000), all children must have up-to-date immunizations before starting care.

The required immunizations are outlined below by age. **This record must be provided by your child's pediatrician on their official form (or via printout) at enrollment.**

REQUIRED IMMUNIZATIONS BY AGE

Vaccine	Infants/Toddlers (0-18 mos)	Preschool (19 mos – 5 yrs)	Required Doses
DTaP	✓	✓	4-5 doses
Polio	✓	✓	3-4 doses
Hepatitis B	✓	✓	3 doses
MMR	(1st dose at 12-15 mos)	✓	1-2 doses
Varicella (Chickenpox)	(1st dose at 12-15 mos)	✓	1-2 doses
Hib	✓	*(if under 5 yrs, may need catch-up)*	3-4 doses
PCV13 (Pneumococcal)	✓	*(if under 5 yrs, may need catch-up)*	4 doses
Rotavirus	✓	–	2-3 doses (by 8 mos)
Influenza (Flu)	✓	✓	Annual (if attending during flu season)

Vaccine	Infants/Toddlers (0-18 mos)	Preschool (19 mos – 5 yrs)	Required Doses
Hepatitis A	–	✓	2 doses (after 12 mos)

NOTES:

- All doses must be **age-appropriate** as per the CDC/MA schedule.
- **Annual flu vaccine** is required for all children **September 1st through March 31st**.
- If your child is **behind schedule**, a **catch-up plan** signed by a physician is required.
- **Medical or Religious Exemptions** must be documented on the official MA form (provided upon request).

ACTION REQUIRED:

1. Provide a **current immunization record** from your pediatrician **before your child's first day**.
2. Provide **updated records** after each new vaccine is administered.
3. Notify us immediately of any **medical exemption** so proper documentation can be filed.

Failure to provide proof of immunizations or an approved exemption may result in the **suspension of care** until documentation is received, as required by law.
